Steering Committee Member Representatives 2009

Following the formula for determining membership of the steering committee revised at the November 2007 steering committee meeting, the composition of the steering committee for 2009 is as follows:

- CARICOM, CIDA, IMF, UNDP – one seat each
- CDB (and all other donors) - one seat
- ECCB – one seat representing the ECCB member countries of Antigua & Barbuda, Dominica, Grenada, St. Kitts & Nevis, St. Lucia and St. Vincent & the Grenadines
- Barbados – one seat (as host country)
- OECS – one seat representing non-ECCB OECS countries and the British Overseas Territories of Anguilla, Bermuda*, the British Virgin Islands, Cayman, Montserrat and the Turks & Caicos Islands, filled on a rotating basis.
- Belize and Guyana* - one seat alternating.
- Jamaica* and Trinidad & Tobago – one seat alternating.
- Suriname* and Haiti – one seat alternating.
- Bahamas* and the Dominican Republic - one seat alternating.
