Over the first quarter of fiscal year (FY) 2026, CARTAC delivered 30 missions and 9 workshops, all aimed at delivering meaningful, measurable, and sustainable impacts to further build capacity across our 23 Caribbean members. Advisors from nine workstreams actively delivered technical assistance to core public institutions in member countries and brought together officials from member countries to participate in topical regional workshops.

### CARTAC Steering Committee Meeting in Belize on June 5-6, 2025

The Steering Committee meeting in Belize focused on CARTAC's funding, strategic direction and capacity development. CARTAC members agreed to equally increase their collective contributions, except for Haiti, to 30 percent of Phase VI's funding requirement. Emphasis was placed on continued donor engagement, and results-based management as CARTAC moves into year two of its Phase VI

workplan. Member countries shared success stories from CARTAC's capacity development (CD), with presentations on Belize's tax administration reforms, ECCB's external sector statistics improvements, Guyana's petroleum customs unit, and Barbados' public financial management enhancements. Development partners commended the CARTAC CD results showcased by the country presenters, underscoring the importance of measurable outcomes in assessing the sustainability and value-for-money of CARTAC's capacity development efforts.
